We have started working with the Advisor of India's PMO for founders of our eco system to get access to matching funds on a Private Public Partnership (PPP) basis and have started dialogue with representatives of sovereign funds of other countries with large markets. Our Investor event at CES was backed by the Govt of Hungary and we expect to attract other EU Govts as well.


